**Sub: Strike off from the Register of Companies of M/s Shongtong Karcham-Wangtoo Transmission Limited (CIN:U40300DL2017GOI310556) & M/s Tanda Transmission Company Limited, (CIN:U74999DL2013GOI257471) (wholly owned subsidiaries of PFC Consulting Limited (PFCCCL))**

Madam/Sir,

This is to inform that the following two wholly owned subsidiaries of PFC Consulting Limited (PFCCCL) (a wholly subsidiary of Power Finance Corporation Limited) has been Struck off from the Register of Companies and the said companies are dissolved on 13.01.2023.

- 1. SHONTONG-KARCHAM-WANGTOO TRANSMISSION LIMITED (SKWTL):**  
Ministry of Power (MoP) vide gazette notification dated 31<sup>st</sup> October, 2016 had appointed PFCCCL as the Bid Process Coordinator (BPC) for the Independent Transmission Project for 'HPPCL 450MW Shontong Karcham HEP' for implementation of Transmission Schemes through Tariff based competitive bidding process (TBCB). Accordingly, PFCCCL incorporated "Shontong-Karcham-Wangtoo Transmission Limited (SKWTL)" on 13<sup>th</sup> January, 2017 for the said purpose. Further, Ministry of Power (MoP) vide gazette notification dated 11<sup>th</sup> September, 2018 de-notified the scheme. Accordingly, the requisite approvals were obtained for winding up/getting the name of company struck off from the records of RoC.
- 2. TANDA TRANSMISSION COMPANY LIMITED (TTCL):**  
Ministry of Power (MoP) vide gazette notification dated 20<sup>th</sup> May, 2013 had appointed PFCCCL as the Bid Process Coordinator (BPC) for the Independent Transmission Project for the Independent Transmission Project for 'ATS for Tanda Expansion TPS (2x660) MW" for implementation of Transmission Schemes through Tariff based competitive bidding process (TBCB). Accordingly, PFCCCL incorporated "Tanda Transmission Company Limited (TTCL)" on 09<sup>th</sup> September, 2013 for the said purpose. Further, Ministry of Power (MoP) vide gazette notification dated 23<sup>rd</sup> February, 2018 de-notified the scheme. Accordingly, the requisite approvals were obtained for winding up/getting the name of company struck off from the records of RoC.

Then, necessary documents were filed with the Registrar of Companies for striking off and dissolution of SKWTL & TTCL from the records of Registrar. Now, MCA vide its 'Notice of Striking off and Dissolution' dated 13.01.2023 has published that pursuant to sub-section (5) of Section 248 of the Companies Act, 2013 the name of M/s SHONGTONG KARCHAM-WANGTOO TRANSMISSION LIMITED and TANDA TRANSMISSION COMPANY LIMITED has 13<sup>th</sup> day of January 2023 been struck off the register of companies and the said Company is dissolved.
