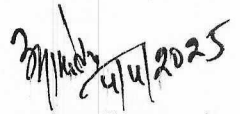

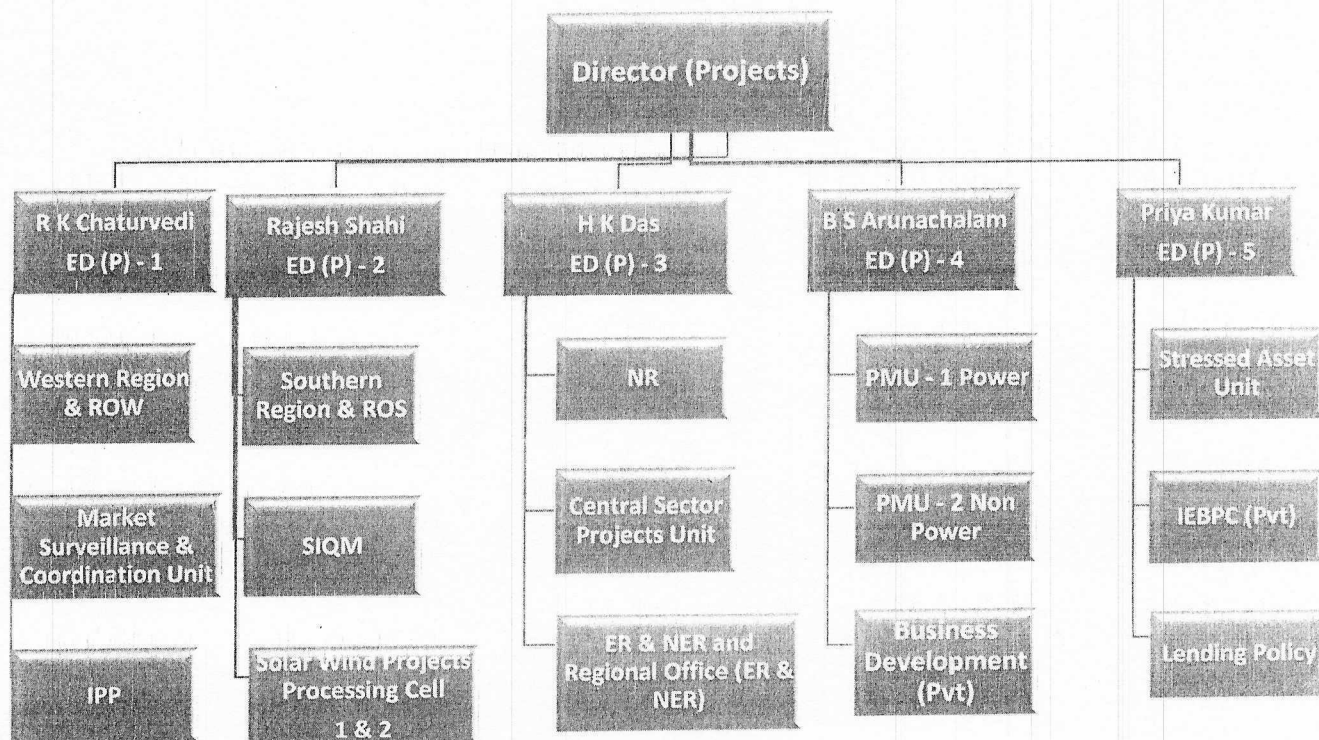

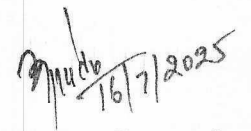

Role & Responsibilities of New Units

Infrastructure & Emerging Business Processing Cell

- Shall handle all private sector loans pertaining to Non-Power Infrastructure (including logistics) & emergent areas like Energy Efficiency, Electric Mobility, BESS, Smart Meters, Green Hydrogen, etc.
- Unit shall look after processing of loans for above category of projects of Private sector, receipt of loan application, preliminary & detailed appraisal, obtaining various approvals of Competent Authority for sanction of loan / modifications of sanction terms pertaining to project division, coordination with borrower and other concerned units in PFC for facilitating sanction, documentation & disbursement of the loan facility, post sanction activities, project monitoring in coordination with PMU, business development in consultation with BDU and any other functions as may be required.
- Private Sector loans previously handled by erstwhile EEC and loans handled by erstwhile IPP & NBU pertaining to Non-Power Infrastructure (including logistics) shall be transferred to Infrastructure & Emerging Business Processing Cell. State / Govt. Sector loans handled by erstwhile EEC shall be transferred to concerned Business Unit.

IPP unit

- Shall handle all private sector loans pertaining to Power Sector (including forward and backward linkages).
- Unit shall look after processing of loans for above category of projects of Private sector, receipt of loan application, preliminary & detailed appraisal, obtaining various approvals of Competent Authority for sanction of loan / modifications of sanction terms pertaining to project division, coordination with borrower and other concerned units in PFC for facilitating sanction, documentation & disbursement of the loan facility, post sanction activities, project monitoring in coordination with PMU, business development in consultation with BDU and any other functions as may be required.
- Loans handled by erstwhile IPP & NBU pertaining to Non-Power Infrastructure (including logistics) shall be transferred to Infrastructure & Emerging Business Processing Cell.

Business Development Unit

- Shall be primarily responsible for Business Development across Private Sector.
- Shall carry out activities towards Opportunity Identification, Client & Stakeholder Engagement, Coordinate initial appraisal, structuring & Outreach, including but not limited to the following:
 - *Undertake continuous scanning of existing and emerging sectors to identify strategic investment and financing opportunities aligned with PFC's mandate. Review relevant policy and regulatory developments, sectoral schemes, and tender announcements to identify potential areas of business opportunities.*
 - *Function as the nodal interface for onboarding new borrowers and business groups, facilitating initial engagement and institutional outreach.*
 - *Maintain sustained and proactive engagement with existing borrower entities to monitor pipeline developments, planned capacity augmentation, and evolving credit requirements.*

- *Monitor the landscape of emerging financial instruments and structures pertinent to PFC's business operations, and coordinate internal deliberations for potential adaptation and product innovation.*
- *Conceptualize and organize / participate in stakeholder conferences / webinars to enhance visibility, build partnerships, and generate business leads.*
- *Facilitate cross-functional knowledge-sharing by conducting regular presentations on borrower profiles, sector insights, and business prospects to relevant internal teams.*
- *Maintain comprehensive Management Information Systems (MIS) covering business development activities, including pipeline tracking, borrower engagement and outreach efforts.*
- IPP, SWPPC, and IEBPC shall be responsible for end-to-end processing of loan proposals pertaining to their respective categories of private sector projects. This shall include preliminary and detailed appraisal of loan applications, securing approvals from the Competent Authority, and coordinating with the borrower and relevant internal units to facilitate loan sanction, documentation, and disbursement. Additionally, these units shall oversee post-sanction activities, business development in consultation with BDU, project monitoring in coordination with PMU, and all other functions necessary for effective project execution and oversight.

Regional Offices (ER & NER)

- Regional Office (ER & NER) at Guwahati shall perform roles and have responsibilities similar to that of RoW and RoS.

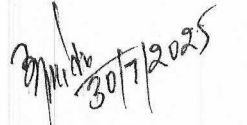

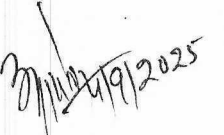

विषय: Re-organization of Commercial Division and Transfer & Postings

Consequent upon promotion of executives and after review of manpower of various units and work allocation, the Competent Authority has approved to re-organize Commercial Division as per chart enclosed at Annexure I.

In view of the re-organisation, the following has been approved by the Competent Authority:

1. To re-organise RDSS Units into 3 units namely
(i) **RDSS - Infra & Distribution, Finance & MoP Co-ordination;**
(ii) **RDSS- Capacity Building; and**
(iii) **RDSS- Smart Metering, Regulatory, Tariff & QM.**
2. To bifurcate Administration & Support Services into two units namely.
(i) **Administration & Support Services-** To look after all the works like event management, administration related activities and library.
(ii) **Procurement Services-** To look after procurement work and allied activities.
3. To bifurcate Human Resource Management into two units namely
(i) **Human Resource Management-** To look after HR policies, recruitment, promotions, employee relations, employee welfare, establishment related matters, etc.
(ii) **Learning & Development (L&D) and Rajbhasha Unit -** To look after employee trainings, training policies, assessment centre, employee development & associated activities and work related to Rajbhasha Unit.
4. To create an additional unit in Entity Appraisal namely **Entity Appraisal-III (EA-III) Unit.**
5. To rename Legal & Document Units as Legal Units (Legal I and Legal –II).
6. To operationalize the above re-organization, the following GMs are designated as Acting HoUs for Units as reflected in the enclosed organogram:
